The Raffle Drawing will be held at a Wine & Cheese Event for all ticket purchasers on Sunday May 16th 2010 from 7-9 PM at Father Patrick O' Kelley Banquet Hall located at 23633 Park St. Dearborn, MI 48124. All entrants must provide a ticket to enter the hall for the Drawing. The Drawing will take place at 8:00 PM. **All numbered ticket stubs sold by 8:00 PM on Wednesday May 12th 2010 will be placed in the pool of ticket stubs from which the winners will be drawn.** The winner(s) will be determined by a random drawing of ticket stubs via a rotating drum. Prizes will be determined in the following order: 1st Prize, 2nd prize, 3rd Prize and only 1 ticket shall be drawn at a time.

If tickets are sold after 8:00 PM on Wednesday May 12th 2010, the purchaser will be provided a full Refund and their ticket will not be part of the pool of tickets for the Drawing on May 16th 2010.

Compliance
